PURPOSE

- These Guidelines are to be used by Project Managers conducting rodent and cat eradication projects based on the PII Resource Kit for Rodent and Cat Eradication.
- The Guidelines cover advice on securing legal consents and other permits to undertake eradication operations on Pacific islands

1. GENERAL

- You may need legal approvals, for example, importation and use of toxins from government departments, and non-legal approvals, for example, access and use of wharfs.
- Some approvals can take a long time, i.e. many years, start applying for approvals as soon as possible.
- You will need to consider National and district laws when seeking approvals.
- The legal approvals and application process will vary from country to country.
- Legal approvals will vary from project to project and will depend on the details of the target species and eradication techniques.
- Given the differences from country to country and between projects it is difficult to produce a definitive list of consents required before a project starts seek advice from other implementing agencies and technical advisors on their experiences.
- Non-legal consents from communities and landowners etc will be included in the stakeholder engagement part of the eradication project.
